confirmed and the permit number is 05-1210. This roof was verified

as meeting the building code requirements outlined on the

mitigation affidavit.

Comments: Inspection verified 1/2" plywood roof deck attached with 8d nails at

a minimum 6" on the edge & 6" in the field.
