Comments: The year of construction was verified as +/- 1980 per Brevard

County Property Appraiser.

2. Roof Covering: FBC Equivalent

Comments: The roof covering was replaced in 2005. The roof permit was

confirmed and the permit number is 05-1210. The flat roof covering was coated with a silicone coating in 2015. This roof was verified as meeting the building code requirements outlined on the mitigation

affidavit.

3. Roof Deck Attachment: Level B

Comments: Inspection verified 1/2" plywood roof deck attached with 8d nails at

a minimum of 6" on the edge & 12" in the field.
