

SEWER EASEMENT

THIS INDENTURE, made and entered into this 29th day of May, 1987, by and between CLUB HACIENDAS CONDOMINIUM ASSOCIATION, INC., a Florida corporation not for profit (the "Grantor"), and LA CITA DEVELOPMENT, INC., a Florida corporation (the "Grantee");

WITNESSETH:

WHEREAS, Grantor is the owner in fee of a tract of land in the County of Brevard, State of Florida, described as follows, to-wit:

SEE EXHIBIT A ATTACHED HERETO AND INCORPORATED HEREIN; and

WHEREAS, Grantee is the owner in fee of a tract of land in the County of Brevard, State of Florida, described as follows, to wit:

Lots 1-6, LA CITA, SECTION 2A, according to the plat thereof, as recorded in Plat Book 33, Page 18, Public Records of Brevard County, Florida.

WHEREAS, Grantee, owner of the above described land, may construct homes upon said property, and in connection therewith Grantee has requested Grantor to provide certain facilities necessary to extend sewer service to said homes and premises and to all consumers who might be served thereby;

WHEREAS, Grantee is desirous of contracting, locating, laying, maintaining, operating, inspecting, altering, improving, repairing, removing and rebuilding pipes, mains, conduits, equipment and accessories necessary and/or desirable in connection therewith, said items being hereinafter collectively referred to as "sewer facilities" for the purpose of conveying, carrying or transmitting water through, over, across and/or under the above described land, which sewer facilities will be located within the specific easement area designated as "15' Sanitary Sewer Easement" shown on the Sketch to Accompany Legal Description (Job. No. 850177), dated June 29, 1987 attached hereto, incorporated herein and by this reference made a part hereof;

NOW, THEREFORE, for and in consideration of certain expenditures on the part of the Grantee in connection with the furnishing of service as hereinbefore indicated, and of the mutual benefits hereunder, and of the mutual covenants and conditions contained herein, the Grantor does hereby grant and convey to Grantee, over, through, across and/or under that specific easement area shown on said drawing and designated thereon, the right, privilege and easement to (1) construct, lay and locate said sewer facilities on said easement area and operate, inspect, alter, improve, maintain, repair and rebuild said sewer facilities thereon and/or remove the same therefrom, and (2) exercise the right of ingress and egress to, over and/or under said lands described in paragraph A hereinabove, at any time and all times for the purpose of exercising the rights and privileges herein granted.

TOGETHER with the rights, easements, privileges and appurtenances in and to said lands which may be required for the full enjoyment of the rights herein granted.

The parties hereto agree as follows:

- 1. Grantee shall have the right to construct, locate, lay, operate, inspect, alter, improve, maintain, repair, remove and rebuild said sewer facilities, together with the rights and privileges necessary and/or convenient for the full use and enjoyment thereof. Provided, however, Grantee shall restore surface areas to their previous condition in the event such areas are damaged by Grantee.
- 2. Grantor shall not utilize or permit the areas in which Grantee's sewer facilities are located to be used in any way or manner which would

create a dangerous condition with respect to said sewer faciltiies, or create any interference with the construction, reconstruction, removal, repair or safe operation and safe maintenance thereof.

- 3. All of the rights and privileges granted hereby shall be and remain in effect in perpetuity unless Grantee shall abandon the use of said sewer facilities, and if abandoned, for any reasonable period of time thereafter for the purpose of removal by the Grantee of any sewer facilities supplied by them. In the event of such abandonment and/or such removal of said sewer facilities, the easement privileges and rights herein granted shall revert to the Grantor.
- 4. Grantor covenants that it has the right to grant the approvals, privileges and easement described or stated herein, and Grantor covenants that Grantee shall have quiet and peaceful use and enjoyment of said easement.

The provisions hereof shall inure to and be binding upon the heirs and/or legal representatives, successors and assigns of the parties hereto, respectively.



SKETCH TO ACCOMPANY LEGAL DESCRIPTION
