CERTIFICATE OF AMENDMENT TO DECLARATION

OF

WHITLEY BAY CONDOMINIUM ASSOCIATION, INC.

Pursuant to Chapter 718, Florida Statutes, and the provisions of the Bylaws of WHITLEY BAY CONDOMINIUM ASSOCIATION, INC. ("Association"), which Association is responsible for the management and operation of WHITLEY BAY, a Condominium, according to the Declaration thereof, as recorded in Official Record Book 5163, Pages 2334 through 2422, Public Records of Brevard County, Florida; and pursuant to a vote of approval as set forth in the Declaration, the Declaration is amended as follows:

1. Article Article X, Paragraph B of the Declaration is amended as follows:

The unit may be rented provided the occupancy is only by one (1) lessee and members of his immediate family and guests. The minimum rental period is ninety (90) one hundred eighty (180) days and the maximum rental period is unrestricted which minimum and maximum rental periods shall not be amended without the approval of at least seventy-five (75%) percent of the unit owners in the condominium (i.e. at least forty-eight (48) of the sixty-four (64) Unit Owners must vote for the modification or amendment) at a duly called meeting of the Association for the purpose of amending the rental restrictions. No rooms may be rented and no transient tenants may be accommodated. No lease of a unit shall release or discharge the owner thereof of compliance with this Section X or any of his other duties as a unit owner. Time sharing of units is prohibited. Ownership of a unit on a monthly or weekly time sharing program is prohibited. Subleasing of units is prohibited. All leases shall be in writing and shall be subject to this Declaration, the Articles of Incorporation, By-Laws, and the Rules and Regulations of the Association and shall be approved by the Association.
