## Note to All Agents

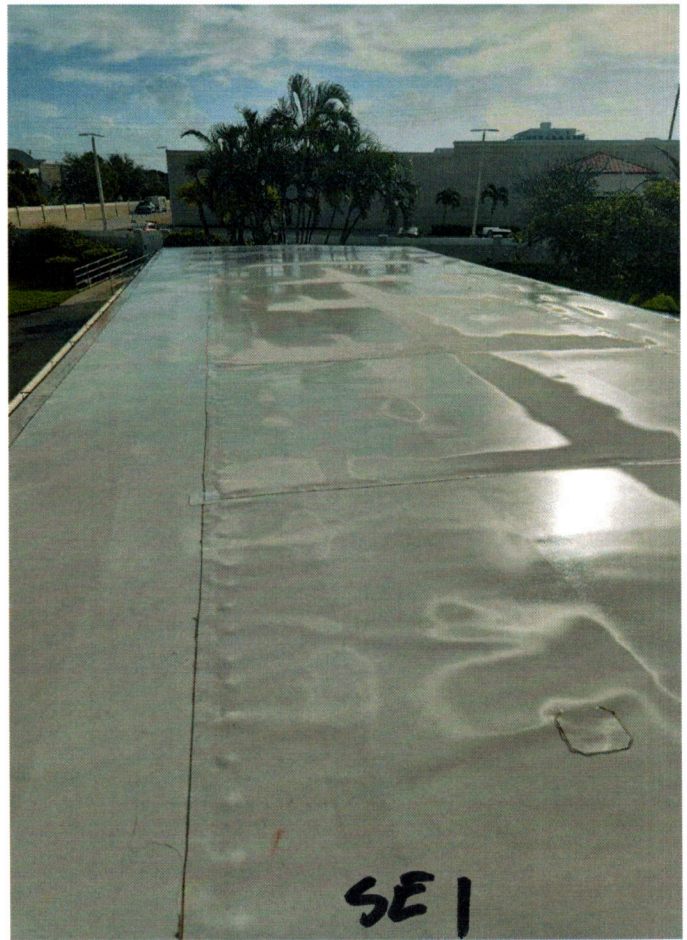
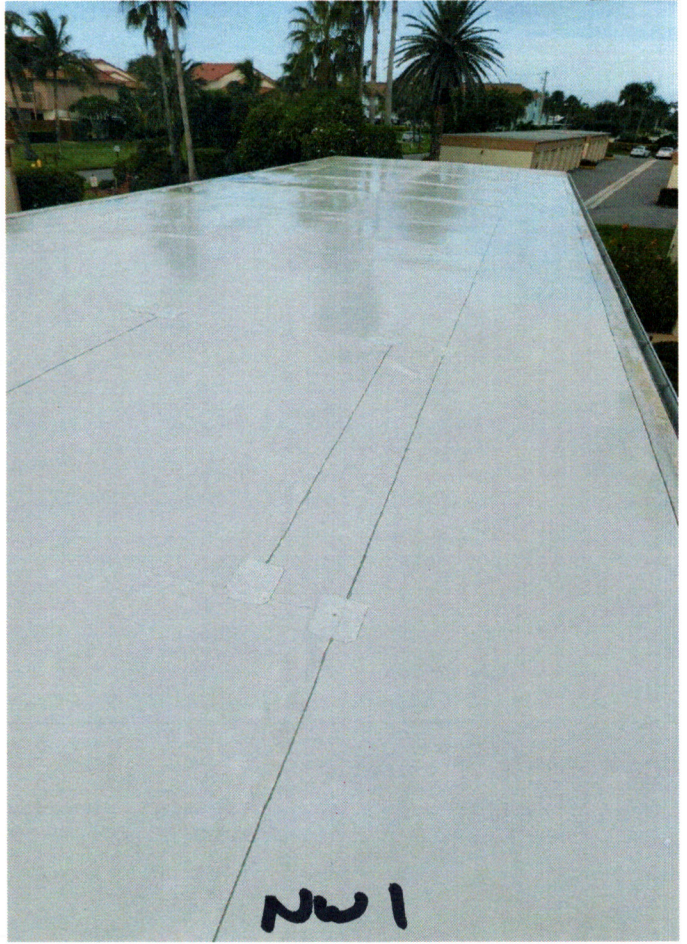
